COMMUNITY CENTRE - REFURB OR REBUILD?

The village hall trustees and the Parish Council have for a while now been conscious that the village hall is in need of major repairs to the roof, the facias and guttering and the floor. Also, the hall is expensive to heat and is not energy efficient.



In response to this, as you might be already aware, the two groups have formed a working group to focus on these concerns made up of two Parish Councillors, a village hall trustee and four residents who responded to the request for people with appropriate skills to help. This working group have now met three times to look at the options and will in due course decide on the best way forward.

The first step, working with MSDC and other agencies, is to understand what work is needed to repair and improve the current building. To this end, there will be a full structural and energy survey with broad costings. Then, with this information to hand, both the trustees and Parish Council can decide on whether it is feasible to repair or whether a new village hall would be the better option.

An important part of the process is to understand what the village would like from the new facilities. This will not only include what is needed from a building but also the recreation ground. In a few months time, the working group will be asking residents for their views. When you do receive a questionnaire, please do respond so the group can make sure they deliver facilities that the village needs. This consultation process is key when making requests for funding.

It will take some time to deliver a new or refurbished building. The working group have been liaising with other villages who have recently gone through this process. Experience suggests this is a project that could take three or four years to deliver.

NOTICE OF VACANCY

Applicants should note that Councillors are expected to attend regular monthly meetings on the third Monday of each month and any additional meetings as may be arranged, and to represent the electors of Wattisfield in raising and discussing those issues of interest and concern on which the Parish Council is empowered to act.

Applicants should also note that membership of the Council is open to those whose residence is in Wattisfield, or within 3 miles of Wattisfield, or whose principal place of work is in Wattisfield, and who are not disqualified because of a criminal record, bankruptcy or involvement in corrupt practices.

Please apply by 10 March 2022 so that applications can be considered at the March Parish Council meeting.
